Chairman Loomis opened the regular meeting at 9:00 a.m. Commissioner Linaweaver made a motion to approve the agenda for April 27, 2015. Commissioner Becker seconded. **All voted aye.**

During Public Input, Ronn Peters, McPherson resident, requested signature on the National Day of Prayer Proclamation. Commissioner Becker made a motion for the Chairman to sign the document as presented. Commissioner Linaweaver seconded. **All voted aye.**

Commissioner Becker made a motion to approve the minutes for April 13, 2015 as presented. Commissioner Linaweaver seconded. **All voted aye.**

Commissioner Linaweaver made a motion to approve the minutes for April 20, 2015 as presented. Commissioner Becker seconded. **Commissioners Becker and Linaweaver voted aye. Chairman Loomis abstained due to his absence at the April 20, 2015 meeting.**
