Chairman Becker opened the regular meeting at 9:00 a.m. Commissioner Loomis made a motion to approve the agenda for January 13, 2020. Commissioner Kueser seconded. **All voted aye.**

During Public Input at 9:00 a.m., Sheriff Montagne updated Commissioners on current inmate counts and department activities.

Commissioner Kueser made a motion to approve the minutes for January 6, 2020. Commissioner Loomis seconded. **All voted aye.**

At 9:08 a.m., Greg Dumars, Lindsborg City Administrator, and Gary Shogren, Lindsborg Development Director, joined the meeting to request approval of a Lindsborg City Resolution for the establishment of a Rural Housing Incentive District, for a maximum of 25 years, for the Stockholm Estates subdivision. Following a review of the proposed plan, Commissioner Kueser made a motion to approve the resolution as presented with the base value being applied to only one lot. Commissioner Loomis seconded. **All voted aye.**
